ELIGIBILITY REQUIREMENTS:

The Certificate 3 Queensland Guarantee program is open to individuals who are:

Not already holding or undertaking a Certificate 3 or higher level qualification (Certificate 3 qualifications completed at school and foundation skills training are not counted)

Queensland residents aged 15 years or over

No longer at school (with the exception of VET in Schools students)

Australian or New Zealand citizens or Australian permanent residents (including humanitarian entrants), or temporary residents with the necessary visa and on the pathway to permanent residency

Employment status does not matter and nor is there any minimum education requirement, only the standard entry requirements for the course of study.

Note: Eligible individuals must understand that the entitlement under the Certificate 3 Guarantee is for one government subsidised training place in a funded Certificate 3 qualification. It is very important that you take the time to consider and compare your training options and costs, before signing an enrolment form or committing to a course of study which will use up your entitlement.

It is a requirement for all individuals participating in a QLD Government Certificate 3 Guarantee funded program to complete a student training and employment survey within three months of completing or discontinuing the qualification they were enrolled into.

The only exceptions to fee conditions are:

SQW participants — this training is provided fee-free to students with any additional costs met through SQW funding

Queensland Year 12 graduates undertaking high priority qualifications — this training is provided fee-free to students

VETIS students — this training is provided fee-free to students with any additional costs met by the school

lower-level vocational qualifications for concessional students — this training can be provided fee-free to students, as determined by the SAS.

The Queensland Government subsidises the cost of undertaking an approved Qualification under this program however all participants will be required to contribute a gap fee (Student Co-contribution) to participate in the program per Certificate 3 Guarantee Guidelines

Availability of funding and available places is subject to change without notice at the discretion of the Queensland Government.

Student Co-contribution payments made with a credit card attract a surcharge per financial institution provider charges (3.3%)

Students can access the Certificate 3 Guarantee through Qld Govt Skills Assure Supplier (SAS) training providers only

All students must complete feedback and survey requirements as a condition of completing the certificate 3 Guarantee program within 3 months of completing their qualification.

Student Contribution Fees must be paid to Ballistic Training Solutions prior to applications being considered. These fees will be refunded (excluding a \$50 administration fee) for unsuccessful applications or credited in full towards another course with Ballistic Training Solutions.
